

# i Light Singapore 2025 – STARLUX Airlines Ticket Giveaway

#### **Terms and Conditions**

These Terms and Conditions ("T&Cs") apply to the *i Light Singapore 2025 STARLUX Airlines Ticket Giveaway* (the "Giveaway"), conducted via the official *i Light Singapore* Instagram account from **31 May 2025 to 21 June 2025**.

#### 1. Eligibility

- 1.1. The Giveaway is open to individuals who are:
  - At least 18 years of age at the time of entry; and
  - Residing in Singapore
- 1.2. Employees of the organiser, its subsidiaries, affiliates, and advertising and promotion agencies and their immediate family members are not eligible to participate in the Giveaway.

## 2. Entry Conditions

- 2.1. To enter the Giveaway, participants must follow the entry instructions provided in the official Instagram post dated **31 May 2025** on the *i Light Singapore* Instagram page.
- 2.2. Only entries submitted in accordance with the stated instructions and within the giveaway period will be considered valid.

#### 3. Winner Selection and Notification

- 3.1. One (1) winner will be selected based on the organiser's internal assessment from all eligible entries received during the Giveaway period.
- 3.2. The winner will be announced via a pinned comment in the **comments section** of the Giveaway post after the conclusion of *i Light Singapore 2025* on 22 June 2025 and notified via **direct message** on Instagram after 4 weeks.
- 3.3. If the selected winner does not respond within **48 hours** of being contacted, the organiser reserves the right to select an alternative winner.



#### 4. Prize

- 4.1. The prize consists of one (1) pair of round-trip Premium Economy airline tickets on Starlux Airlines, traveling from Singapore to the United States of America (valued at S\$10,950). The itinerary includes a layover at Taipei Taoyuan International Airport (TPE) both on the outbound and return flights, with the route as follows:
  - Outbound: Singapore (SIN) to Taipei (TPE), then Taipei (TPE) to USA
  - Return: USA to Taipei (TPE), then Taipei (TPE) to Singapore (SIN)
- 4.2. The prize is:
  - Non-transferable,
  - Non-refundable, and
  - Not exchangeable for cash or any other item.
- 4.3. The tickets are valid for travel until **15th October 2025** and must be used before this date. Travel dates are subject to availability and cannot be changed once confirmed.
- 4.4. The prize does not include any other costs or expenses, including but not limited to:
  - Accommodation:
  - Meals;
  - Local transportation, or
  - Any incidental or personal expenses.
- 4.5. The winner will be solely responsible for all costs and liabilities related to airfare taxes, cancellations, no-shows, and failure to meet any travel requirements, including any applicable penalties.
- 4.6. To redeem the prize, the winner must provide their **full name**, **contact details**, **and confirmed travel dates** to the organiser. No amendments will be accepted once the travel dates have been submitted unless tickets are unavailable based on travel dates.



#### 5. Publicity

By entering the Giveaway, participants consent to the use of their **name**, **Instagram handle**, **photos and/or videos** by the organiser for promotional, publicity and marketing purposes in any media, without compensation or further notice.

## 6. Limitation of Liability

The organiser is not responsible for:

- Any technical issues or failures;
- Lost, late, incomplete or incorrect entries;
- Errors in winner notification or prize delivery; or
- Any other issues beyond its reasonable control that may affect the operation of the Giveaway.

## 7. Right to Modify or Cancel

The organiser reserves the right to:

- Modify or suspend the Giveaway; and/or
- Cancel the Giveaway at any time, for any reason, without prior notice.

## 8. Governing Law

These Terms and Conditions shall be governed by and construed in accordance with the laws of **Singapore**, and participants agree to submit to the exclusive jurisdiction of the Singapore courts.

#### 9. Release

By participating in the Giveaway, participants agree to release and hold harmless the organiser, its subsidiaries, affiliates, advertising and promotion agencies, and their respective officers, directors, employees, and agents from and against any claims, losses, damages or liabilities arising from or in connection with the Giveaway or the acceptance, use or misuse of the prize.



## 10. Acceptance of Terms

Participation in the Giveaway constitutes full and unconditional **acceptance of these Terms and Conditions**. The organiser's decision on all matters relating to the Giveaway, including the winner selection, is final and binding.
